| 1. | <p>RPTKA (Foreign Worker Utilization Plan) A plan for the utilization of foreign workers in specific positions, prepared by the employer of foreign workers for a specific period and approved by the minister responsible for labor affairs or a designated official.</p> | 5 - 7 Hari Kerja |
| 2. | <p>Notification (formerly IMTA) This is an approval for the employment of foreign workers issued by the Director General of Labor Placement and Employment Opportunity Expansion, serving as the basis for the issuance of an ITAS. Includes: DPKK Notification & IMTA Notification</p> | 3 - 5 Hari Kerja |
| 3. | <p>Telex Visa is a written document issued by an authorized official at a diplomatic mission of the Republic of Indonesia or another location designated by the Government of the Republic of Indonesia, containing approval for a foreign national to travel to Indonesian territory and serving as the basis for the issuance of a residence permit. Includes: Limited Stay Visa, Visit Visa (Single/Multiple), Investor Visa.</p> | 2 - 5 Hari Kerja |
| 4. | <p>Residence Permit A permit granted to certain foreign nationals to stay and reside in Indonesian territory for a specified period of time for the purpose of employment. Includes: Limited Stay Permit, Permanent Stay Permit</p> | 2 - 5 Hari Kerja (ITAS) |
| 5. | <p>MERP (Multiple Re-entry Permit) A written permit issued by an immigration official to foreign nationals holding a residence permit (temporary or permanent) to re-enter Indonesian territory.</p> | 2 - 5 Hari Kerja |
| 6. | <p>STM (Registration Certificate) This is an arrival registration document issued by the local police station corresponding to the foreign national's place of residence while they are in the territory of the Republic of Indonesia.</p> | TBC |
| 7. | <p>SKTT (Certificate of Residence) This is a temporary identification card for foreign nationals issued by the Population and Civil Registration Office, with a validity period corresponding to that of the ITAS.</p> | TBC |
| 8. | <p>LKOA (Foreign National Presence Report) This is a report submitted to the local Subdistrict Office or Manpower Office based on the location of the company where the foreign national works within Indonesia.</p> | TBC |
| 9. | <p>Other Services Services related to permits for foreign nationals, foreign workers, and companies. Including: Passports, EPO, Non-Return ERP, Company OSS, WLKP, and others</p> | TBC |
